
## Hendersonville Samaritan Association

## A Client's Story:

Heartbreak is only one portion of this client's story. In September we met Sue. She came to us through a series of referrals from friends, social workers, and a sister agency. Sue is a full time homemaker for her husband and five children. Her husband, Bill, worked hard to provide for his family. In August, he was rushed to the hospital and quickly diagnosed with kidney failure and terminal acute leukemia myeloma. Within a month every aspect of this family's life was forever changed.

Sue was juggling her husband's illness, her children's needs, household management, and emotional trauma. We quickly helped with utilities, food needs and networking with representatives of her husband's employer.

Through these interviews and conversations, it was determined that we could relieve Sue of a heavy burden by helping her with Christmas for her children. She was spending most of her time ferrying Bill to doctors and dialysis. The reports on his prognosis were shortening from an initial four months to one or two months.

A local church immediately agreed to adopt this family for Christmas. We interviewed Sue and encouraged her to provide a wish list for the kids. Our Church partners very generously insisted that we give them a wish list from the parents as well.

Sue was overwhelmed with this kind offer. During the course of our conversation, she said that her only request was an inexpensive video camera so that Bill could make tapes for the children to watch as they grew up.

At the beginning of November the HSA Staff discussed this simple request, with a great amount of emotion, and decided that we would use a small amount of the donated funds for Christmas to purchase a video camera and give it to Sue well ahead of Christmas. This decision was a great blessing to the family because Bill slipped away early in December. He was able to leave his legacy of love and encouragement to his young children because of this simple gift.

The children received a great blessing of gifts and encouragement from our church partner and a lasting gift of loving memories from their Dad.
